## TRAVEL TIPS

University of Florida faculty, researchers, and staff often travel internationally as part of their official UF duties. Depending upon your destination, what you intend to bring with you, or your planned activities, you may need to obtain a license or other authorization from the U.S. government before your trip.

In addition to your departmental approval process, there are three steps you need to take before you embark on an international trip. Please click [here](#) to get more information.

If you are a faculty director/advisor who will be leading a study abroad trip this year, you will be designated as a Campus Security Authority (CSA) for the duration of the trip. You are required to take the University of Florida's CSA training prior to your departure. ## Office of Clery Act Compliance

The Office of Clery Act Compliance at the University of Florida has recently enacted a new travel portal that will need to be utilized for all university sponsored student travel that is either for more than one night or which occurs in spaces that are used on at least an annual basis. The information entered into the portal will provide the Office of Clery Act Compliance with the information required to solicit crime statistics from the applicable law enforcement agencies that oversee each location. Any faculty/staff who will be leading trips are also designated as Campus Security Authorities (CSAs) and are required to view UF's CSA Training video prior to departing for the trip. ## UF Privacy

Do you know how to identify and report a privacy violation? There are 3 types of privacy disclosures, incidental, accidental, and intentional. While incidental disclosures (i.e. inadvertently clicking on the wrong student's record) are not violations per se, accidental and intentional disclosures often violate various privacy rules and need to be reported immediately. When in doubt, just report.

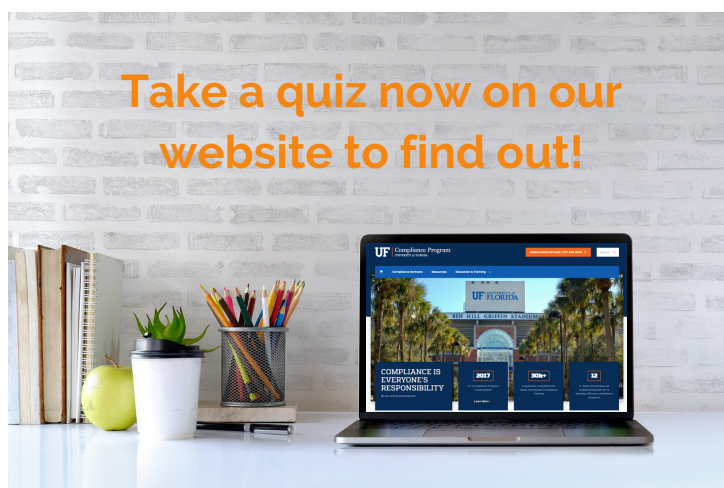
